AGREEMENT TO OUR LEGAL TERMS

We are APR CORPORATION ("**Company**," "**we**," "**us**," "**our**"), a company registered in 300 Olympic-ro, Songpa-gu, Seoul, Republic of Korea.

We operate a digital platform, including our website and mobile application (collectively, the "**Platform**"), as well as any other related products and services that refer or link to these legal terms (the "**Legal Terms**") (collectively, the "**Services**").

These Legal Terms constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("**you**"), and APR CORPORATION, concerning your access to and use of the Services. You agree that by accessing the Services, you have read, understood, and agreed to be bound by all of these Legal Terms. IF YOU DO NOT AGREE WITH ALL OF THESE LEGAL TERMS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SERVICES AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Services from time to time are hereby expressly incorporated herein by reference. 9. GUIDELINES FOR MEMBERSHIP PONITS

Our member points refer to the mileage points awarded by the "Company" to registered members based on criteria set within the "Platform." These points can be used to purchase discount coupons for affiliated stores specified by the "Service".

The usage method is determined according to the announcements in the "Service" or these terms, and the criteria for awarding member points may change depending on our operational policies. Use License
